Thank you, Sally. It certainly great to be back. It is always good to have you and your long-standing partner in social justice and or Allison Thorn on the program. Important things to us just to be sure. Can I ask if it's okay to ask which pronoun to use if any? Yes, I use the pronoun pronouns. She her. And the question that is most important, so saved it to last, which Aboriginal land or

Ends are you won't coming in from today? Via the the zoom waves as we'll call them. I'm on the land of the grand jury. People of the kulin nation. Good to have you with us from there. And again, welcome to any Aboriginal and Torres Strait Islander people tuning in or any First Nations. People could be anywhere in the world, which is in this day and age of Technology, but that's actually a good lead-in to why I wanted to have you on the show.

So today because you've got an event coming up where events took place, if I have it, you know, if we have a right in America that could have some very helpful relevance for those campaigning for various forms of social justice in Australia, and you've got your own event coming up to discuss those in great detail. Next Sunday, the 7th at 4 p.m. Australian Eastern, but tell us about what sort of what about the sort of history that has we wanted to talk about.

Okay. Well, first of all, I think the title of the event sort of gives a good idea of all of this and the title of it is fire up to beat the religious freedom, Bill inspired by global fights for Reproductive justice. So, what we are looking at and firing up here, is the fact that

Abortion rights, but not just abortion. Rights Reproductive Rights. Generally for everyone are very much Under Fire globally. Not just in Australia. So we have been watching some massive, Global battles over.

Abortion rights, which of course is tied to all other forms of Reproductive Rights and recently radical women in the United States held, a fascinating very inspiring online Forum that involved Reproductive Rights Warriors from Ireland, Argentina, as well, as the United States.

Listeners might be aware of how much it took for Ireland to finally abortion rights against just massive Powers, but also in Argentina. That was another absolutely long long hard-fought fight which they want.

As well, nevertheless, we realized that when you win these such a right as to abortion against such enormous powers that are fighting tooth and nail against you. You don't get everything you want. But the point is that what they succeeded in doing in Ireland and in Argentina was too. Absolutely bust a huge hole in in that

In that brick wall in the United States again, listeners, probably know that the national right to abortion that women have had since 1973 is under very very great threat. In fact, just from this early this month, the Supreme Court over there started hearing.

A case coming from Mississippi. The point of that case is to judge whether or not to revoke that National right for women to have abortions. So, of course, the Supreme Court is stacked now with a majority of Hardline far-right conservatives, so that's why

This is such a momentous time and such a historic fight to have. It's expected that the Supreme Court will be well, they won't be saying anything at about about it till till next year, but the fight is well and truly on so that this online Forum, that radical women held in late August, we had speakers.

Hers from Ireland and from Argentina in the United States, pulling together, the experience of fighting from the ground and what we're going to be hearing next Sunday. The 7th of November from 4 o'clock is we're going to be on seeing a recording of those presentations because

Because we can learn a lot from them here, the threat to abortion rights and Reproductive Rights in general, are kept under the radar. It's not really on our mind very much, but it's very much. They're like, even with or without this so-called religious freedom, Bill, women's access to abortion.

Has become more and more limited for example, Marie stopes, which is the largest abortion provider in the country. Just had to close its clinics for for financial reasons. So and I must say, when we talk about abortion rights or Reproductive Rights in general. We must be including trans and non-binary people in all ways.

It has as well as women with with disabilities. Because these are important, you know, groups of people who are left out of the picture but whose, you know, Reproductive Rights are just as front and center as anybody else's. So that's a no, that's just needs to be understood that this

Is what we're talking about. We're talking about the entire breadth of everybody who is who has every right to refill reproductive Freedom. Yeah, bodily autonomy, which is big issues for Trans and gender diverse. And there's actually something I saw online and it's in today's age about the rights for chance children, which is not quite the same, but while one or two ballparks across and trans people have a right, of course to

Be themselves and of course, all sorts of people regardless of gender identity need to have their Reproductive Rights protected. So it's a great linkage. You know, I just wanted to clarify one point apart from the Helen Stokes Clinic closing. I just wanted to get a little more detail on where the Australian attack on Australian abortion and Reproductive Rights or that child rephrase that reproductive including abortion rights where things might be going backwards. Just that under the radar words. What else?

Is going on just before we move to the next part of our conversation. Yeah, thanks for asking. That's a lie. Well, for example, women in rural areas have actually very limited access to abortion and general Reproductive Rights, but particularly abortion. This has to do partly with any services.

That want the sort of existed no longer existing. For example, for example, up on the border of Victoria and New South Wales in Albury. There was a clinic there that had to close some time ago. So it's that, that dearth of services in rural areas, but also just the cost because it means that women need to

Rural areas need to come to the city and everything that that means they have yesterday. So on and so forth. The other part of it too is that it's expensive, you know, I mean to have a termination where you know, if you're sort of looking at that at the moment, it gets more and more expensive. The more you are into your pregnancy, and it's

It's prohibitive. It's prohibitive for so, so many women especially, you know, young women and none, young non-binary people, but also just who were just simply pour. So while we legally have abortion rights. They're they're kind of well, they're there.

Limited with other barriers. Unseen, Barrios, unseen until you go through this situation yourself, so that that's, that's what those are. But also just to add to that and I guess this brings us to the so-called religious freedom bill, which is that organizations have been Exempted from anti-discrimination law on just about every single front and this

Odes, you know, reproductive Health, including abortion. So, you know, any, anybody fronting up to a an abortion provider? Sorry to adopt her, I should say, could be turned away. Even though the Victorian law says, they can't turn someone away. They have to refer them to someone else. But yes, so there are those exemptions to deal with

Well, yeah, certainly existing in most jurisdictions in Australia. Although Tasmania has the least religious exemptions from anti discrimination or anywhere in the country. And let's have a nice gentle suddenly southerly Breeze, blow across the Bass Strait. But it also raises a point that the, you know, the some of the religious discrimination bills that have been proposed up until now would oh we're would override any state anti-discrimination law protections.

Exemptions and we can progress on that area as well which, you know, is an issue. So there's lots to be, you know, what, from what we've seen in the past to be concerned about and I wanted to talk about that and then how that, how that links in the whole

religious discrimination Bill. And yes Igbtiq, A+ people, women people with disabilities Reproductive Rights. There's many, many groups effect that that's only the

Now, this sort of the tip of it all, but it really effects, if the federal laws override State and are weaker, then in most cases that's going to take away. A lot of the basic structure of anti-discrimination. Laws one that comes to mind is the precedent the the sorry a principle of ever equal opportunity law in Australia, whether it's in an apt or not to quote section, 10 of the Victorian. Law motive is irrelevant. So people can't do, so horrible things and it's odd, but it didn't mean it to be nasty and then just walk away.

So, there's a lot of things to be concerned about for lots of people. So, in that light, how can the reproductive rights fight that is going on in America that you heard about and you've got the event at four pm Australian Daylight Savings Time. Next Sunday, the seventh, how can that link into what we need to do here, to make sure that our rights are not pushed backwards. Absolutely. Well, what came out of that form that I referred to before.

Was a massive National mobilization across the United States. That will radical women. Initiated, and it was really quite exciting to watch, October 3rd was the day set for that National mobilization because that was the anniversary of the death of Rosie Jimenez. The

Woman in the United States to die from a backyard abortion, due to the government. They're withdrawing Federal funding for abortion. She died in 1977. So it was partly in commemoration of Rosie Jimenez, but it was also the day before, The Supreme Court was going to be starting its hearing of that of that, Mississippi Law, so,

So what came out of that that National mobilization it was

So many organizations coming together to endorse and to organize all sorts of actions that day, unions came, onboard other feminist organizations, immigrant groups, lgbtiq, etcetera, Etc. In various different ways, depending on, you know, where they were worked together to do various.

Action, so, the actions were spreading from Naperville, Illinois. To Lexington, Kentucky, to Phoenix, Arizona to, you know, New York, Los Angeles, San Francisco and so on. And those actions were anything from on a a protest rally to a vigil to a letter writing, you know, campaign depending on what the resources were of the

People who were were running it. So it was really quite exciting to see this coming together of so many parts of the movements. It was a multi-issue. It was taken on as a multi-issue issue, a multi-issue fight. And, and it didn't stop on October 3rd, because when something like that just explodes

Onto the scene for a day. It doesn't stop and I know that what's going on over there now is that all of these organizations that came together and I really emphasize the importance of unions who came in on it as well. All of those who came together are now mapping out. What are they going to do in the next several months? Because

This is going to be going on for absolute months. Watched January 22nd this next year, which is, of course, the the anniversary of Roe versus the Roe versus Wade, Supreme Court decision of 1973. So, things are hopping over there and I think that that's what we can be running over here on as as well as we learned from the fight and in Ireland and Argentina, it's, um,

Lessons being learned it R22, just

Just pull out all stops be out there. Don't let a pandemic stop you because it certainly didn't stop anybody in Ireland, Argentina or the United States. We it's time that we we we call a less these movements. Anyway, this could be one of those things. There are other issues that we should be coalescing around to. This is hardly the

You only won but this religious freedom bill.

That we have to gear up for is definitely something that requires a united front. Absolutely. It sets back. A lot of people and I'm glad you mentioned unions. 3ci has of course a proud history of connection to the Trade union movement. And I think there's implications there that. I mean, for example, I mean this the thing that I've always been bothered by the the I'll call it again, the religious discrimination so-called.

Logistics criminalization building, its previous forms. Let's say in a workplace person of religion. A says to personal religion, including belief in, no religion at all person. Be your religion, stupid. And then B says, to, I know yours is stupid. Who's discriminating against tomb? It just seems absolutely unworkable. That's going to make for workplace health and safety issues for for workers. So it's not going to make the workplace. Any better easier. More productive is just one example, a little facetious as it might appear.

Here, but of course then we as we said we've got all these groups of intersection or people who are going to be affected and it's just, you know, hugely problematic and so I'd you're right. We do need to connect, make sure that we're sort of working together, obviously can have different perspectives within a broad framework and that's important. The more we can get the better and can overcome this. So it is really, really important.

The people are involved any other thoughts on the responding to that but also any other thoughts that you have about the whole situation Debbie. Yeah, you know when you mention the workplace I can imagine a whole lot of problems. So it's the one that you mentioned such as What If an employer

Doesn't like hmm trans people or doesn't like uppity women or doesn't like most lumps. What if an anti union worker who doesn't want to join a union decides that just by Union delegate coming up to say, do you want

Join the union that that person could say that person that delegate has offended, my my religious commitment to join a union. It can get to that point and I don't think that anything which it may sound absurd, such absurdities can become realities or just the hiring and firing of people.

An employer can claim, you know, that, that moral principle that such and such a person.

As far as the importance is concerned, doesn't fit in that workplace. So I really I really fear fear for workers rights on many levels if this bill actually wins. Well, we're just going

to make sure that it doesn't. But that's that's the workplace. But we can extend that to just any aspect of life, you know, like you know, what, if you going, what if

What if you're a woman who goes into a pharmacy? It needs some morning after pill. Mmm, you know, what's the pharmacist? Just won't give it to you. What if a, what if they

A young woman goes to a doctor and either wants well, once the contraceptive pill the doctor says not, you're too young for this I and and so on. What if any any of us who ever, we may be whatever our particular situation is can imagine any situation that we would be facing.

If This Were to go through well very very true in a couple of other scenarios that have been touted a trans person who's now that let's use a current example, there's suddenly now able to go traveling, oh, I've got to get a prohormone prescription, going to a pharmacy that they don't normally go to. Now, my religious belief says can't serve you. What happens there? What happens in a workplace that let's say wants to be, I'll say, Igbti friendly, they hire carefully. The person says, yes, I support Igbti people.

And then 18 months or whatever into their tenure. They suddenly find religion. How do you get rid of them? If they don't support the organization's values, you know, they can't stay there and disrupt, everyone's work. Just it just seems like I'm not as much as I hate using a military analogy. The the far-right, the Conservative Christian, right? Those sorts of people just seem to be intent on throwing landmines into the path of progress. So we have to make sure that we sort of, you know, stop their land mines landing on.

And so this is just one part of it. That seeing is the go and I suppose, there is one other question. That's come to mind. It's been disconcerting for me that the Australian labor party which in the current Parliament will say, now it has not they haven't, you know, they're their opposition to such a bill and any dangerous Provisions therein would be critical yet. They seem very, very quiet on this. That's just something that's, you know, I find very very

Anxiety provoking. And so, there's another angle in there as well.

You know, I think that that's a terribly important point and that kind of links to something that was going through my mind when you were talking earlier, Sally, that if we only need to look at the United States and we can look elsewhere as well. But well, I'm more familiar with its what's going on in the United States. In terms of the

What is it? Absolute impunity, that the far right? Has where they, and that's where this bill that we're facing here comes from, there's a buildup of a, an organized far, right? That is just going to go. As far as it can go. It takes encouragement from what's going on, say,

In the United States and what the, you know, far right has been able to do there within the laws within the halls of legislators. And that when we think of it, when we come up with examples of that sound absurd to us that the, the impunity of being able to assert that.

To bigotry comes from a confidence that the far right. Has now it's linked to what you were just asking about the Labour party, I think because the Labour party we have seen all through, just the whole thing of marriage. Equality going, way back to the days of you know, Howard and everything just sitting on their hands because they

They do not want to upset what they think is a status quo, which they're making into a status quo, which is that that religious bigotry and they will not upset that religious bigotry. It's it's

It is absolutely. I don't know what the word is for, besides unconscionable, but it's just absolutely telling all. I'm sure I listeners can think of other words. I won't repeat them on here. I'll be nice. But seriously, we do need to pressure it. We do need to pressure the Alp and make sure at least that they refer any Bill to a senate inquiry. So, and that is open and transparent. So it can be

Just and make sure that that happens. And I think that should happen regardless of what people think of the bill. It has to be carefully scrutinized because it's a major piece of legislation. So that's one step but also get them keep building. The pressure on them, to outright oppose it, and make sure that this phony culture War doesn't become an

election issue, which, of course Could Happen. Well, now, we're within about nine months or so give or take of it happening. So, there's lots of people can do, they can

Put the pressure on the Alp. They can get involved in connect with Grassroots movements such as yours and of course they can find out more detail on what they can do. Let's get those event details. Once again, if we've got it. Cut. If we've got everything covered. Let's get those details on how people can attend at four pm, next Sunday online.

Absolutely. Well, this is how people can attend they can. If they're on Facebook, go to radical woman's face book. That is radical women Australia. If they don't have access to Facebook, just email us and I'll give our email address. It's our w dot a US, Australia.

Worse. Yeah, at radical women. One word dot org. So that's our w dot, a u.s. At radical women dot-org and they're in for a treat because they're going to be hearing some very, very inspiring presentations coming from Ireland, Argentina. The United States, as I said, but will be speaking as well.

Addressing all of that in relation to firing up to the for the fight against the religious freedom Bill, and what's really important about this online meeting is that this is for everyone to bring their ideas because this is about firing up ready for a fight against that religious freedom bill, which I think is still expected to

Tabled in December, although I don't think we've heard anything concrete, but it's coming. It's on the way. And while I'd like first, I want to give kudos to be Igbtiq plus Community for having lead the fight against this so far, but it's got to be all about everybody in on it. It and again, as we said before, the union movement has to come in on this.

Big time. Yeah. Well, absolutely. We need every idea every milligram strength we can to make sure that this doesn't send us backwards. One of our awesome listeners, which is of course through all three. See our listeners are awesome. It said I really hope we don't emulate those American values here. We are Australian and still call out. Extremely far right groups. Yep. We need to do more than call them out. We need to make sure they don't get any further. And also said Health, perfect.

Health professionals must abide by the Hippocratic Oath, unlike small business owners. So I hope that most will do that and a good example and I think this is an example. It says we can do it, American Senator. Ted Cruz was called out by a politician, are here over some of the, his stupid comments over covid. So I think that's, you know, shows that Australians are still willing to sort of his as here's, as crude as I get an Australian to have an ability to see through.

Bullshit. And I think that that's an account of characteristic, we can use in this fight Devi.

Yes, I'm sorry. I didn't mean to interrupt you, but that's all right. I just wanted to, and in terms of American values, actually. These are you American? It's we're living in a capitalist society, which is very binary, very sexist, as well as racist and everything else. And the far right is

Movement that has been able to build up steam in this capitalist society that will got so that and it's the capitalist patriarchal nuclear family, that those values that, that were up against and it's a, it's a global, it's a global fight and it's certainly well and truly fight to be had here.

Yeah, now it's it's a society that no capitalism just often doesn't really treat people with kindness and in any and or in an inclusive way. So we need to make sure that we fight this sort of Bill that just really does not add value to human dignity. Debbie, if we've got everything covered.
