Now thousands, let's have a look at this, you know, sort of technically, possibly. Correct. The article starts thousands of Victorians have changed gender on official documents without undergoing medical procedures. Since a new law was introduced to make the processes easier more than 2,700 people, including children have made changes to their birth certificate. Since the new law came into effect in 2020.

Now, let's just stop and have a look at that. The laws came into effect in early May 2020. So that's about four years. They've got four years Financial years worth of data 800 a year. So yeah, it's thousands over four years. But it's not even a thousand a year and that's data released by the Registrar of births, deaths and marriages. I think of great interest here for Trans people then we get to something. Yes, a bit better up to 43% of people to changed and I'm quoting the article here with these words, change their gender from male to female 33% from female to male and 25 percent change their identity to other. Now, that may not be the term used, you can use any term under Victorian or provided it's not frivolous or vexatious or offensive or something like that.

And so that, you know, assumes what we've always known in the trans and gender diverse communities. That there is this kaleidoscope of gender, and gender, identity, and gender expression. And this talks about gender identity. And now, you've largely got now, 43 percent of the fact that it's 25% in the middle. It's, I'm surprised a little surprised at in from assigned male, identifying as female to 33%. I mean, it's slightly big variation, but it's still relatively even. And according to the laws applicants are required to assign a statutory declaration. Well, that's not quite true. The applicant doesn't someone who's known the person for more than 12 months have to and it does this article In fairness does say children are able to change the marker with the consent of a parent or Guardian.

And well, declaring night. Why didn't get any payment for this or anything? Declaring, my interest, the figures have been welcomed by algae BT, Q, i+, Advocates diversity, Consultants a league on, the do who's that. Welcome. The new saying it means the law and Society has affirmed who they are, which is very helpful, both practically and in mental health terms, they said, oh I don't use they, but I could be could things could be worse. I could be of a, I don't rely don't identify as non-binary, but I should

Taps been proactive and told them I pronounce the reporters Kelly, Douglas and Alex white to whom I spoke. But I use sheep and they expected the figures to rise, to continue to rise as trans. People became more accepted in society and transgender Victoria CEO dr. Song Vivian said, said those Figures were also likely to continue Rising people. Particularly young people are exploring, their gender diversity, potentially because that is, they feel more supported and they have been previously. So, yes, we do expect to see more.

So nice that we've had trans people and gender diverse people quoted. We then have the usual so-called balanced, some medical experts have said the moves could create problems when it call came to treating people for certain conditions where a person was not forthcoming about their gender. Well, the reasons people aren't forthcoming about gender identity in health settings is because they don't feel they're going to get the right service and you know, we've popped that

And some sort of, you know, you know, the answer is to educate people. So people feel comfortable. And the way to do a good way to do that is ask pronouns first, which means you get the gender identity, right? Only asked for how someone was assigned at Birth or their current physical body, when it's relevant. If I've got a

You know, broken finger, why do you need to know how I was assigned at Birth or what my? It's on my birth certificate. Now, I don't really think it makes a lot of difference. And the legend says, here in this article, the again, this so-called balanced approach legislation to adopt the change, caused a stir in 2019. After the Victorian, women's Guild raised concerned. The reforms could threaten the safety of vulnerable women and compromise. Women's only spaces, I would like to know

There's ever been if anyone out there can find independently verifiable evidence such as a court case where there's been a problem like this. I haven't heard of it and I've been involved in the trans and queer communities for twenty nine and a half years nearly 30 Goodness, Me and the changes followed similar moves in the ACT. South Australia. Well, Western Australia, Tasmania Northern Territory and Queensland. Now it should be noted that the changes in West Australia and Queensland happened after Victoria and the Queensland law, since they've been in 250 people made alterations to their birth certificate in the first six months. So that's looking kind of similar allowing for variation of population.

So look, I have to say I've seen worst articles and seen a lot worse in Murdock media, in my time. That's overwhelmingly fair, you know, sort of, I suppose they have to do the balance. They don't even thankfully quote so-called medical experts, obviously. And it is fair to say that I, and probably a large percentage of trans people would disappear disagree, with the views of the Victorian Women's Guild, and I don't, as a side note really see, there's a lot. Any any, I will say any evidence or lot or logic to back that, and this has been this crying wolf on the threats to women for as long. Well, since I came out and pride obviously before, and I really think enough is enough on that.

One should be added though, alone. Not getting it. Not in this article. That changes that went through the West Australian Parliament recently have given some upgrade to West Australian laws. The long outdated, gender reassignment board has been abolished, but the duodenum medical sign off in Western Australia. And there's well, I have to get some trans people from Western Australia on the show to talk about that there was controversy about whether those changes were enough. Now, some people will say get through what you can now without controversy, and then do the rest later. The question is, when does later come? Because the other side of the coin is that people will say, I will, we did that a few years ago. We don't want to go back to it again. Mmm. So I'd love to hear from if there are any trans and gender diverse people or supportive family members over in the west, who sort of are able to talk to that. That would be very, very cool. We've had a message in from Rainbow reporter, roving reporter. I beg, your pardon roving wrote the first one, which connects to the story. I've just discussed who reads newspapers these days. The peel and the Australian Human Rights Commission says, the peels are few right to refuse heterosexual people, and this is both heterosexual men and women was granted to help gay men achieve equality and would seem that my reading of this article is that all the lesbian action group says that, you know, they are seeking to discriminate. They say, the quote from this article says, the lesbian action groups Council Leigh Howard said, we are seeking to discriminate and this head on behalf of his clients were female and we'd like some rights please.
