Lots of things to discuss on the show today. Going to look at an article that came up to sort of touches on to the area of pinkwashing, which I know you can be controversial. One, that's sort of needs to get debated, but I think it would be also have some catchup from when I was in last week. I'm not in last week. I beg your pardon, and I want our wonderful, because our listeners and 3 CR, of course, never has regular listeners. We just have awesome ones. And I've got comments from Jenny and roving reporter to look at.

However, I think it's impossible to not this week look at the social media ban and the effects on queers. How has this come about the whole caboodle as best as I can from my perspectives and knowledge and look at it from a queer perspective. And there's been a couple of good articles around on this that have been of relevance and I wanted to just sort of go through those because I think they've been sort of that they're written by young queer people. One of which is from six media is one of the ones that came up and just trying to bring it up. Has we had lib live because we're how I'm just having a few laptop issues which are always fun, but I think that, you know, I really I've heard, you know, the are a lot of the arguments and I just cannot agree with this ban. Here we go. Here's one yesterday from the Saturday paper, and this is the one by the article by Maggie Perry, from six media on and directly goes to my heart. How the how the social media ban harms children, and by 6:00 news reporter Maggie Perry who write starts her article. So it starts the article. I'll get to pronouns in a second. Very hard to be a trance fifteenyear-old in central, Queensland friends, and her nose at 6:00 news, have been there every step of the way. And interestingly, two years ago, p.m. Albanese, he labeled 6 News headed by then fourteen-yearold, Leonardo, pull easy, a fantastic initiative.

And then Maggie goes on to right now Labour's. Very own legislation, Leo and every child under 16 including me would be blocked from using almost every social media application. And, you know, sort of sorry. Maggie goes on to say that rural communities would be disadvantaged particularly if they're in small conservative communities. Yep. And we know that for both generally for queer, people has been and

With varying degrees in issue. Now, sort of social media has emerged as a Lifeline for the socially axis exiled, you know, sort of and, you know, it's Maggie. Also goes on to say, many rely on. Social media is a safe space. I have friends yet to come out to heavily religious, or conservative families, gives people social support. And Maggie has said,

Said, quote, I've content note mention of abuse, quote, I've heard stories of kids in Suburban Sydney, who would likely suffer abuse at the hands of their Partners if they're non-heterosexual identity was to be uncovered others. You may be accepted at home, suffer harassment and discrimination at school working on the streets. This is not you. So why should the government let down the most vulnerable and most disadvantaged? Why would the government remove the only safe space? That thousands of Children at Risk depend upon so desperately

Support, make it goes on to say, this isn't to deny that social media account can be a significant mental hindrance in terms of body image, and then gets the guts of it. The problem lies in the fact that labor, rather than to, rather than attempting to tackle the negatives of social media. Through education and government funded, programs has taken the easiest Sledgehammer solution of a blanket ban for under 16's. Effectively wiping out support groups for the young and isolated.

So and then goes on to say Labor's continuous attempts to appeal. So the two supposedly popular ideas without much practical consideration or assessment mean it is missed. The fact that this band will not only have significant social effects but hamper. The young ability of young people to learn the skills that come fully with you fully using the internet, which are vital for the future Fern in terms of employment and other things. So, and

And there's going to be a divide in terms of technological skills reiterates, popular support approach. And a sort of this off course, the debate about, whether we'll have to hand over documents, which I'll come back to in a second, what a reasonable steps to verifying someone's age. And if the labor party party room can't work, how we're going to enforce this in terms of documents how the hell's it going to work which I also want to come back to? Yeah.

The now sort of bill has now got through and there's lots of implications of it and including some personal ones well-written Maggie. I would, as a say, I agree with pretty much everything. You've said there and some thoughts that I hadn't had I hadn't thought about the economic skills. One, that's a very, very good one indeed. Well, well, thought out,

And, you know, I just, I can't agree with this from a queer perspective, which is what this shows about. As I agree with that, it's a sledgehammer, you know, and it's sort of a very blunt instrument approach that I don't think is the answer and misses out on the benefits for lots of people. And I'm, you know, I'm, I'm not affected directly in this way, but I think,

I think people with various forms of disability, physical mental health, various forms of neurodivergent, would be oval face negative effects from this legislation. But I also, you know, I was thinking about my own story, you know, someone who didn't come out until I was 29 and didn't have access to end there. Obviously wasn't internet back then, but couldn't get information.

And now I'm still uncovering beliefs, as a person that have hindered me all my life at 59 and so the longer it takes to come out first. Let's say in terms of I'll just stick to gender identity expression and sexual romantic orientation because variation of sex characteristics, isn't my experience and there are, I think differences for variation of sex characteristics. Longer it takes the more of this backlog.

It's there. It's harder when it comes out because it's like a big you know sort of well volcano of emotion that blows itself up in your face. And I just think this is really, really disastrous and you know I wish I had been able to come out earlier. I can't change my life. I don't get to sort of you know, sort of

Instead of ice occasionally, do get sad and frustrated that I sometimes feel that my life wasn't what it could have been. And, you know, I just think like this is a backward step and the fact that people will have to wait, 16, you may have to wait 16 years to get to their real life to have that backlog of emotion out of formative time because these beliefs have dug in deep. They've

Acted me. I've never had a chance to look them because first, I had to deal with gender identity and expression. And do you have to do I have surgery or not? And then sexual and romantic orientation. And then neurodivergent sat this, got buried under these beliefs, I had as a person about myself, which I'm still very raw or about it. The moment of won't discuss got buried. And I've mentioned that I haven't been well in the program, I am struggling with mental health because of this. So here you have at least one case

It's my case, amongst all the queries, and I know there are others who are probably in the same boat, who are suffering from, what I'll call, Barry trauma, whether more to do as a person and perhaps the coming out type of stuff and I just think this is a hugely backward, step, I'm going to have a breather. They're all I've got another article on it from the conversation, from a trans perspective, and other things. But you know, hopefully,

Well, we opened up today with Wendy Rule and the rattlesnake. We need the rattlesnakes wisdom, in my opinion. Let's have another track. my dad was so conservative about it, I saw a happy couple together and I was like this is actually this actually doesn't seem like the terrible thing. I'm told it is, you know. So this is sort of an interviewing this

Trans teen and they re emphasize the role the specific and much-needed role in the lives of Australia's trans youth. They talk about the mental health disparity, which is due to discrimination, and they talked about Sam's upbringing and religion telling them that being gay was a sin. No formal education about transgender and they found out stuff on Instagram.

So you know, this is the thing that, you know, very few things are all or nothing and this Sledgehammer approach has taken away the good as well as the bad. And so Sam story is one of just several examples that emerged from their research and now the government's legislation. Well it says, it will prevent with it. I'm going to say will try to prevent under-16s from creating accounts on sites such as insta, Snapchat and Tick-Tock and which part which

Platforms, will be included. Know what's to stop worse platforms? That, you know, are even more risky and people going there or finding their way around it. One person who when I, you know, sort of, I'll say gently vented to this an older person said, younger people are Adept at finding their ways around technology. I still check the fax machine every morning in case something is coming. No, that's not true. I don't have a fax machine but you know, maybe they are

Sort of this article then goes on to say the band's feasibility has also been challenged as young people will find workarounds to continue accessing them. There's been talk about whether it's unconstitutional unconstitutional as that as Daffy. Duck, I think or Bugs Bunny. Once said I chose, I'm not a youth now at that sort of thing. Yeah. Now because it would could stop freedom of political expression. So,

Now, I this I just can't agree with this, but the question then if it's, there's so many logical arguments. Why has it gone on? Well, that's where we get into the illogicality is of politics. And, you know what, this seems to come down to is that traditional media who are worried about the threat of social media, particularly with younger people, being more Adept, not believing the what they see, as the Malarkey, put out by mainstream commercial media in particular, I found there,

Platform. So hey let's cut young people off from social media, they'll might have to read our garbage or not. Get anything else. Gee that's in interests of media. No wonder the Liberal Party supported it, because younger people tend to be more Progressive. So, that means, they'll have less access to Progressive information. But or theoretically, but the out someone once said, I remember there was a piece of research on young people, 15 years ago, where our very youngest person preteen said

We know what they're not telling us. So I think they will find a way around it and I just think this is window, dressing, it's not clear how it's enforceable is my thought, you know, you know, how can you be forced to hand over something like a driver's license? What happens if you don't have a driver's license? And obviously most under 16's. What I think most under sixteen twenty now you're going to verify

Will the government sort of key card thing or whatever it's called work? I don't know. Yeah, lot, welcome. Your thoughts and we have some here, the fabulous roving reporters, come in and said it's a complex issue where I've sadly seen bullying in queer circles as well friends. Grandparents were newly arrived migrants who experienced extreme bullying, the conservative 53, to the seventies, and they survive with no help at all with a no racial protection laws and they do survive.

Despite the trauma and still suffered to this doll. Come back to that. Why can't parents that better skills to protect their kids bullying still occurs in the plate by ground especially with class. I think this decision is purely political and there's a reason why Australia is the only country to pass it. Roving reporter? Yeah. Well now I agree that. Yeah. Like yes, it's nice that you survived despite from a wouldn't be nice if we can prevent it I suppose it's my first thought the school the school yard one. I mean you know the research

Sighs to my knowledge that that's unsafe. Most unsafe place for queer kids is school. So what? We're going to not send secure, let's not get into kids to school. Oh no, we can't do that. And that word I think is

worth something else comes in. I think there's a huge degree of paternalism and you know, patriarchy patriarchy going on here, controlling women and controlling children, as elements of men try to control women. I think that's a fact.

You're in it as well. And the conservative right Catholic Rite of the Alp, must have some part in this and I'd be interested if you're willing to come back roving, a reason. Why strata is the only country to do it, is it? I'm just going to say if you're willing to respond, I'd love to have your response back in. You know, I also have to say that I'm disappointed that any out queer politician in the federal Parliament could have voted for. It was interesting. When it got to the Senate Penny Wong, didn't happen to be in the chamber.

Not that her record on supporting queer stuff. Is that great? Which I've think I've discussed in my opinion on this show, before I think she's very good in terms of Foreign Relations, but as someone who known, you don't not every career politician has to be queer supportive, but suppose she wanted to win powder, very disappointed. See one prominent Progressive. Queer politician in the chamber, voting for it. I'm not going to name names. I don't see a point but I think that's really sad.

Sad. And I'm going to say this, I think that sad as it is to say somewhere the politicians who voted for, it will have some queer young blood on their hands. Big comment, not often get that intense. But I think this is not the right thing to do. It's just political gutless nurse against big powers of mainstream dying mainstream media and just shows perhaps some how mainstream media is? So unhealthy.

Leave that one there unless there's more comments coming in on it, I'll come back to comments from roving last week and also look at some pinkwashing also an issue that Jenny raised whilst I wasn't in last week, but a certain movie has hit your streaming services. But young people have a right to express themselves online, and seek information, social media offers children and young people benefits such as inclusion, social connections sense of belonging also, which can support their mental health, bang on roving and Amnesty International.
